1. CHECK ALL HAND RAILS AND PLATFORM FOR CONDITION: Inspect to make sure they are fastened to the floor and in good working operation, and no gaps in floor padding or carpet that could cause tripping hazard.							
2. CHECK ALL SPRINGS: Visually inspect springs on each attraction. Elongated springs will show signs of excessive stretch.							
3. CHECK ALL PADS: Safety pads need to be cleaned daily with common cleaner. Also make sure pads are secured safely to the frame underneath by tightening bungee cables.							
4. CHECK ALL FABRICS: The trampoline fabric needs to be cleaned with common cleaner daily. Also check for holes, splits, or excessive elongation.							
5. CHECK ALL BOLTS AND NUTS FOR TIGHTNESS: Listen for squeaks as you move throughout. Will need to tighten all nuts and bolts if there is excessive squeaking.							
7. REMOVE ALL DEBRIS AND MOISTURE: Inspect all attractions to removed trash and wipe down excess moisture. ie. Sweat.
