## Subsidizing Corporate Membership

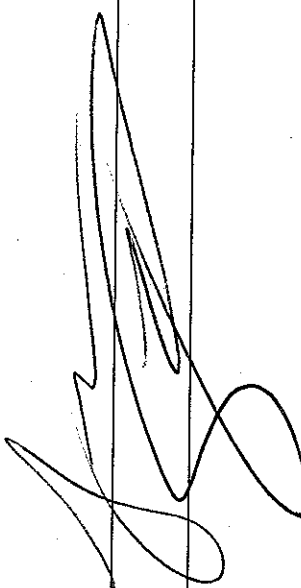
