### **Spa Membership Membership Agreement and Waiver of Claims**

### ARTICLE III - Membership

**Section 1. Nature of Membership.** Membership is a non-transferable right which confers on Member the sole right to use and enjoy the Club facilities in accordance with the rules and regulations as adopted and/or amended by the Club for the Good Life.

### ARTICLE IV. MONTHLY RATES AND CHARGES

**Section 1. Charges.** Upon approved application, members and their guests may be extended credit to use Club services or goods. Credit terms may be changed as warranted.

(a) Online Services System. The Club has an Online Services System where a member is able to electronically pay dues and charges, access Club services and commit the member to services or other Club amenities (such as massage reservations) without personal interaction with Club staff. Member understands and agrees that by using the Club's Online Services System, member will be bound by any such electronic commitment pursuant to the terms and conditions of this membership agreement and as set forth in the Uniform Electronic Transactions Act (AS 09.80.010 et seq.) until such time as the member withdraws, in writing, from the Club's Online Services System.
