FRONT DESK STAFF:

- 1. Any physical therapist entering the club with a member or non-member must first identify themselves at the front desk, showing identification/proof of their employment with the approved clinic.
- 2. Front Desk staff should verify the name and clinic are on the approved list posted on myTAC.net.
- 3. If the patient the therapist is accompanying into the club is an existing member, the therapist must sign the guest register. NOTE: NO GUEST FEE IS COLLECTED
- 4. If the patient is a non-member, they must also sign the guest register and present a signed recommendation for exercise from their therapist to the membership department at the time of first entry to receive two 1-week passes.
- 5. The therapist and client may use the club for two-weeks, signing the guest register each time they enter (unless client is a member, in which case they do not need to sign). NO GUEST FEES ARE COLLECTED.

MEMBERSHIP STAFF:

- 1. Any non-member entering the club with an approved physical therapist will, upon first entry, present a signed recommendation for exercise from their approved therapist.
- 2. The non-member should then receive two 1-week passes with noted expiration date two-weeks following date of first entry.
- 3. Contact information for the non-member will be recorded in a log for tracking.
- 4. The non-member will receive information about the \$0 enrollment offer and benefits and amenities of becoming an The Alaska Club member during their first visit.
- 5. NOTE: The special offer must be contracted prior to the end of the two-week pass period.
