What we are doing?

New members will be given New Member Temporary Cards at the point of sale by membership. This pass will replace yellow receipt stickers.

Membership:

- 1. Provide new member with a New Member Temporary Card at the point of sale.
- 2. Fill in member name, member number, join date and membership coordinator name.
- 3. Track New Member Temporary Card on Temporary Card tracking sheet (attached).
- 4. Inform the new member that the card will allow them access to the club for 7 days. Permanent scan cards must be activated at the front desk within 7 days of their join date and is the responsibility of the member.
- 5. Bring pass to the front desk and scan into the system.

For additional passes contact Jessica in Marketing at 264-2734 or jmehl@thealaskaclub.com. Tracking sheets must be turned in before new passes are issued.

Front Desk:

New Member Temporary cards are an easy way to identify new members. When presented with a temporary membership card, the front desk should:

- 1. Greet and welcome the new member to the club. Inquire if they have visited before or if they have questions.
- 2. Look up member name in CSI. If they are in CSI, issue a permanent scan card. Drop temporary card into till drop.
- 3. If they are not in CSI, ask them to scan the temporary card and fill out the guest register.
- 4. Temporary cards expires seven days after join date. Call membership for assistance if presented with an expired Temporary Card. Membership will research the issue.

Do not turn away member's expired cards. Ask a manager to help you research the status of the new member.
